
This memorandum is to be distributed to all probate judges within the State of Connecticut.

Pursuant to C.G.S. Chapter 319i Sec. 17a-543(i), I hereby demand that you halt all involuntary electroshock treatment procedures, for we shall pray for the individuals being subjected to such measures beginning now and beyond.

Please provide notice, as it be your civic duty to do so, that though the Universal Life Church Monastery granted me the requisite authority to liberate the persecuted individuals held in your mental health facilities from involuntary psychiatric treatment when they ordained me a minister under a non-denominational flag, belief in me alone is sufficient to receive my prayer.

As for the forced drugging, feel free to continue. Perhaps they deserve it.

C.G.S. Chapter 319i Sec. 17a-543(i)

Unless there is a serious risk of harm to the patient or others, based upon the patient's past history or current condition, nothing in this section authorizes any form of involuntary medical, psychological or psychiatric treatment of any patient who in the sincere practice of his or her religious beliefs is being treated by prayer alone in accordance with the principles and practices of a church or religious denomination by a duly accredited practitioner or ordained minister, priest or rabbi thereof. The Department of Mental Health and Addiction Services shall adopt regulations, in accordance with chapter 54, to implement the purposes of this subsection.

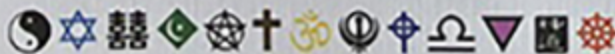
